## COR@L RESUMPTION AND OTHER RELATED PORTALS

Labuan FSA is pleased to announce that the online systems – COR@L will resume its operation on 2 October 2023.

- 2. Submission of Forms and other request can be lodged at this link <a href="https://www.lfsacoral.gov.my">www.lfsacoral.gov.my</a>. As part of the enhanced security measure, kindly find below the actions to be taken by all users when COR@L go live.
  - i. Password Refresh: Please kindly reset COR@L access password by clicking "Forgotten Password" in the sign-in page. A notification email will be sent to your email address for further action.
  - ii. Security Access Control:
    - a. There will be an additional time-based control to access COR@L system from 7am-7pm MYT (Mon-Fri);
    - b. IP-based Geolocation restricted to Malaysia's address only.
- 3. All payment needs to be made via Lepay platform. All authorized users are required to register new user account at <a href="https://lepay.labuanfsa.gov.my">https://lepay.labuanfsa.gov.my</a>.
- 4. The platform for Beneficial Ownership can be accessed at https://pearl.labuanfsa.gov.my. User is required to register new user account.

- 5. Reefs portal at <a href="www.lfsacoral.gov.my/reefs">www.lfsacoral.gov.my/reefs</a> will be disabled temporarily until all the profiles in COR@L are completely updated and the status of entities are verified.
- 6. Users may experience some technical issues due to COR@L resumption as per the following:
  - a. Incomplete data in the profile
  - b. email notification on reminder and Struck off notice addressed to director's email and resident secretary. Kindly ignore the email if the payment has been made.
- 7. The progress of data migration and profile's update together with Frequently Asked Question (FAQ) are attached in Appendix A.
